1	Further to our online meeting yesterday could you kindly provide us further clarifications regarding the points D (valid CISRS accreditation certificate) and F (latest CISRS audit report) under Section 2 (2.1 General Provision) sub section 2.1.4 Eligibility criteria.	Mr. Sandeep Pakhrin Lama	Both the documents mentioned in D & F in Section 2 (2.1.4 Eligibility criteria) are the <b>mandatory documents</b> . Failure to submit both the documents will disqualify the bidder for technical assessment.  D – is the accreditation certificate provided by CISRS to conduct the assessment  F – is the audit report (physical verification report) of ACs verified by CISRS to award accreditation.
